Subject: Amendments to the Operational guidelines of the "Mission for Aatmanirbharta in Pulses" for Processing and Packaging units under Post-harvest Infrastructure component –reg. Sir,


I am to refer the issue related to the subject mentioned above and to convey the approval of the competent authority regarding the amendments to the Operational guidelines of the "Mission for Aatmanirbharta in Pulses" with respect to the Processing and Packaging units under Post-harvest Infrastructure component. The amended provisions under Existing Guidelines will be as under:

Provisions under Existing Guidelines (Page 45, Point 5.8 and Sub-point 5.8.1)	Amended Clause
Financial assistance will only be provided for plant and machinery, excluding the costs for land & building, power or manpower, etc upto the 33% of the project cost, subject to a maximum limit of ₹25 lakh per unit whichever is less.	Financial assistance will be provided for plant and machinery and construction of building / warehouse /storage infrastructure, excluding costs of land, power or manpower, etc upto the 33% of the project cost, subject to a maximum limit of ₹25 lakh per unit whichever is less. Maximum share of subsidy for the construction of building /warehouse /storage infrastructure shall be 30% of the total eligible subsidy amount, i.e., 33% of the project cost or 25 Lakh, whichever is less.

Note: The remaining project cost may be mobilized by the other means as mentioned in the SOP (para 4, point 4.2)
